| <input type="checkbox"/> | The courtyard wall overall height will not exceed four feet (4'-0") above the adjacent paving or finished grade, measured to the top of the wall or cap. | <input type="checkbox"/> |
| <input type="checkbox"/> | The overall height of pillars and/or pilasters is no more than six inches (6") higher than the wall. | <input type="checkbox"/> |
| <input type="checkbox"/> | Pillar and courtyard wall caps, do not exceed four inches (4") in height. | <input type="checkbox"/> |
| <input type="checkbox"/> | Decorative metal or wrought iron gates are no higher than the wall or pillar/pilaster. | <input type="checkbox"/> |
| <input type="checkbox"/> | Single or double decorative metal or wrought iron gates will not total more than forty-eight inches (48") wide. Double gates are permitted at courtyard walls only. | <input type="checkbox"/> |
| <input type="checkbox"/> | The timeline for completion of work is within 90 calendar days from the start of work and must be completed before the one-year approved application period expires. | <input type="checkbox"/> |
